## **REGULATIONS**

### ***ARTICLE 1: DEFINITION OF THE EVENT***

**1.1** The David Warren Classic Tour is a touring car assembly for cars manufactured prior to 1st January 1980. Any other vehicles, including replica cars, may be included at the discretion of the organisers. It is not a competition. Plus any vehicle of the marque of any of the formally invited Clubs.

**1.2** The event will take place on Sunday 21st July 2024

### ***ARTICLE 2: ORGANISATION***

**2.1** The event is organised by the BURNHAM-ON-SEA MOTOR CLUB LIMITED

### ***ARTICLE 3: ROUTE***

**3.1** The route will be approximately 65 miles in the Somerset area.

**3.2** The start will be in the St Dunstons Car Park, Glastonbury, Somerset (BA6 9EH) (Next to the Abbey)

**3.3** An overall time allowance will be given for the route.

**3.4** Entrants will be issued with a route book detailing the tour route. The onus of following the correct route rests with the entrant.

#### ***ARTICLE 4: ELIGIBLE VEHICLES AND NUMBER OF STARTERS***

**4.1** The event is open to all vehicles as defined in Article 1.1

**4.2** All vehicles must be correctly registered, currently licensed, have a valid MOT certificate and be in a road-worthy condition. TRADE PLATES ARE FORBIDDEN

**4.3** Light commercial vehicles, which in the opinion of the organisers are likely to add interest to the event, are permitted.

**4.4** Up to 40 vehicles will be permitted to start the David Warren Classic Tour.

**4.5** NO ADVERTISING, TRADE SIGNS OR PROMOTION DISPLAYS MAY BE CARRIED ON OR DISTRIBUTED FROM ANY VEHICLE WITHOUT PRIOR CONSENT, IN WRITING, OF THE ORGANISERS.

#### ***ARTICLE 5: ELIGIBLE ENTRANTS AND DRIVERS***

**5.1** Any individual or any organisation may enter the event.

**5.2** The entrant must sign the entry form.

**5.3** All drivers must hold a valid full driving licence for the vehicle being driven. A competition licence is not required.

**5.4** Only drivers nominated on the Entry Form are permitted to drive.

#### ***ARTICLE 6: ENTRIES***

**6.1** Entries close on Sunday 14th July 2024.

**6.2** -

**6.3** Any change of vehicle should be notified before the closing date.

**6.4** Entries should be submitted on the official Entry Form, signed and sent with entry fee - paid online to:

**6.5** The organisers may refuse entry without giving a reason.

**6.6** If the entry is oversubscribed the organisers may select entries on giving the best representation of age, model and manufacture. A reserve list may be established.

**6.7** The selection of entries is at the absolute discretion of the organisers and their decision is final.

### ***ARTICLE 7: INSURANCE***

**7.1** Entrants and drivers must have valid insurance in accordance with the requirements of the Road Traffic Act and the relevant law applicable in Great Britain.

**7.2** Entrants and drivers will be required to sign a declaration that they are covered by such insurance.

### ***ARTICLE 8: IDENTIFICATION***

**8.1** Each entrant will be supplied with a Rally Plate, individually numbered, which must be displayed at the front of the vehicle for the duration of the event. This will be supplied by the organisers at signing on.

### ***ARTICLE 9: FORMALITIES***

**9.1** At the start entrants will be required to sign on and register with the organisers. Entrants must ensure their vehicle is roadworthy and they have a current road fund licence, MOT certificate and insurance. All drivers must have the appropriate licence to the cover the vehicle entered.

**9.2** Any vehicle which does not comply with the regulations or,

which in the opinion of the organisers, is deemed to be inappropriate for the event, will be forbidden to start.

**9.3** Passengers may be carried up to the number for which proper seating is provided.

### ***ARTICLE 10: START AND FINISH***

**10.1** The starting order will be as indicated on the final instructions sent to each entrant during the week prior to the event.

**10.2** Cars will leave the start from approximately 9.25 am at regular intervals from Glastonbury, Somerset (BA6 9EH).

**10.3** Exact starting times will be notified by Email.

**10.4** Cars must be at the start 40 minutes before their scheduled start time to allow time to sign on, fix the rally plate and have breakfast.
